ENCLOSED SAMPLE OF RECOVERED UNIDENTIFIABLE EXTRA-TERRESTRIAL MATERIAL WAS FOUND BY A RANCHER JUST OUTSIDE ROSWELL, NM. RANCHER CLAIMS TO HAVE SEEN STRANGE LIGHTS IN THE SKY, FOLLOWED BY A LOUD EXPLOSION. OBJECT WAS FOUND THE FOLLOWING DAY AT WHAT RANCHER CLAIMED WAS A "UFO CRASH SITE".

INVESTIGATION BY AUTHORIZED AIR FORCE AUTHORITIES CAST DOUBT UPON THIS CLAIM. OFFICIAL AIR FORCE INVESTIGATORS CONTEND THE "LIGHTS" WERE MOST LIKELY METEORS AND THE DEBRIS AT THE "CRASH SITE" IS PROBABLY FROM A STANDARD TEST WEATHER BALLOON. MAY HAVE BEEN USED TO DELIVER STRANGE AND DISGUSTING FROZEN LACTATE PRODUCTS FOR CONSUMPTION BY ALIENS DURING OBSERVATION OF TRITE AND BORING ELECTRONIC INFORMATION DISPLAYED ON VARIOUS TYPES OF VIDEO MONITORS (SEE REPORT TV666-DVD FOR FULL ANALYSIS OF ALIEN VIDEO AND HOLOGRAPHIC EQUIPMENT).
